

THE GREAT BIG FRIENDLY FUEL GIVEAWAY

CONTEST PARAMETERS

South Dakotans can submit an eligible nominee (14 years old or older) to win one of (9) \$100 or (1) \$500 Friendly Fuel gas money Kwik Star gift cards. Total prizes will amount to \$1,400. The promotional area is limited to residents of South Dakota. Gas gift cards provided by Kwik Star.

ELIGIBILITY OUTLINE

- Minimum Age to Enter: 14 years old.
- Geography: Nominees must be a full-time resident of South Dakota.
- Nomination Guidelines:
 - Ask your friend permission to nominate them for the giveaway.
 - Limit one nominee per entry submission.
 - Entries without legitimate contact information for the nominee or nominator will be disqualified.

HOW TO ENTER

- Complete:
 - An entry form located on the TheFriendlyFuel.com website.
 - and/or:
 - A physical entry at **4712 S Technopolis Dr, Sioux Falls, SD 57106**
- Entrants can submit a short statement explaining how their friend fuels their friendship or goes the extra mile. Entries are short and informal.
- Submitting an optional photo submission (of the nominator and friend/nominee) on the online entry form will count as an additional entry to the nomination. Non-legitimate photo entries will not be valid for additional entry.
 - Submitting a photo constitutes permission for use of photo in contest promotion (see “General Conditions”).
- Open to legal residents of South Dakota, 14+. Void where prohibited. Ends 06/07/24, 12:00:00 PM CST.
- Contest participants may not win more than once during the promotional period. However, if not initially selected, they may re-enter the following week.

DISCLAIMERS

Winners will be required to show a South Dakota photo ID to confirm age and residency before claiming gift cards. Should the winner not have a valid South Dakota Identification Card, they may submit alternative documentation, such as a utility bill with a South Dakota address or a current student ID from a South Dakota school district. This can be submitted at an agreed upon time during business hours via video call (Facetime/Teams/Zoom) with a Flynn Wright representative or presented in person at the Flynn Wright office in Sioux Falls.

Employees of South Dakota Corn/Flynn Wright/Kwik Star and their immediate family are not eligible to win. Current and past board members of the South Dakota Corn Growers Association and/or the South Dakota Corn Utilization Council and their immediate family are not eligible to win. Persons who have refunded their corn checkoff dollars in the last marketing year and their immediate family are not eligible to win.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

NUMBER OF WINNERS

- Total number of winners will not exceed 10.
 - Nine (9) winners will be eligible to receive one \$100 Kwik Star gas gift card.
 - The final, grand prize winner will be eligible to receive one \$500 Kwik Star gas gift card.

METHOD OF SELECTION OF WINNERS

- Nine (9) winners will be eligible to receive one \$100 Kwik Star gas gift card and one (1) final, grand prize winner will be eligible to receive one \$500 Kwik Star gas gift card.
 - Each Friday, starting April 12, 2024, a winner will be drawn at random from that week's submissions for each \$100 gift card giveaway. Winners will be determined by a random drawing from all eligible entries received during the previous week (Friday through Thursday).
 - On Friday, June 7 (the last week of the giveaway), the final \$500 grand prize winner will be randomly selected from the total pool of nominees entered each of the previous weeks. Previous winners who received a \$100 gift card will not be eligible for the final grand prize drawing. This winner will be announced on Saturday, June 08, 2024.
- Winners will be contacted via phone or text.
- Final deadline for receipt of entries: June 07, 2024, at 12 PM CST
- Promotion Period:
 - Promotion begins April 8, 2024, at 8 AM CST
 - Promotion ends June 07, 2024, at 12 PM CST
- Entries are accepted as soon as the previous drawing ends through midnight the night before. For example, if drawings take place at noon on Friday, all entries for the next week's prize would be accepted Friday, after 12 PM

through the next Thursday at 11:59PM CST, (excluding the final grand prize winner, which will be selected from the entire pool of entrants on the last day of the promotional period).

- Presence Requirement: Winners do not need be present to win; however, winners are encouraged to post to social media when they receive the gift card or when they use the gift card.

DEADLINE FOR CLAIMING/REDEEMING PRIZES

- Gift cards will be mailed or sent electronically to each winner within one business week of phone/text notification and after all eligibility requirements are met.
- Any winner that does not provide necessary information may void prize without any further prize consideration.

ALTERNATE WINNERS

If a potential winner does not qualify, declines acceptance of prize, or is unreachable/unavailable, a new winner may be selected by random drawing from all eligible entries.
